Nutritionals for all items can be found on our online menu system.

- À la Carte purchases are an out of pocket expense and are not covered under the Free and Reduced lunch program.

 No À la Carte purchases can be made without money in account.
- > At the High and Middle school level, if extra portions are taken, there will be a \$.75 cent extra charge per portion.
- For additional entrees/sandwiches, there is an additional \$2.75 charge.
- > Students that bring lunch from home are able to purchase a carton of milk for \$.50.
- > Free and Reduce eligible students bringing a lunch from home may purchase a milk for \$.50
- Breakfast is available at all Elementary Schools. No need to come early.

The Payor of the food service account will be able to view the current balance, last payment, email balance notification option, as well as detailed information on all purchases your child had made during the school year.

Payment Information

Each student has a pin number in our computerized debit lunch system. Students enter their pin and the cost of the purchase is deducted from their family's lunch account. Cash purchases are not allowed at the point of service.

NOTE: Deposits made are placed in the family account which will cover all children under that account and may take up to 48 hours to post to your account.

Ways to make Payments:

➤ Online using RevTrak - Visit RevTrak on the district website. There is \$2.95 fee per transaction.

Please read the instruction page completely before attempting to make an online payment.

> Pay by cash or check with no transaction fee. Deposit envelopes can be found in each school office.

The Slinger Food and Nutrition Dept. uses an automated call out program to contact families when account balances fall to \$8.00 or less. Email reminders are also available within Family Access, under the tab for Email Notifications.

Negative Account Policy

No Å la Carte purchases can be made without money in account. If a family account is more that -\$50.00, a bag lunch consisting of a sandwich, fruit, carrots, and milk may be provided to students and accounts will be charged. The bag lunch will be delivered to the student prior to lunch service. Our Department will make every effort to inform families through an automated system or personal calls. In addition, if you need help to complete a Free or Reduced application; please do not hesitate to call us.

Meal Assistance/Free or Reduced-Priced Lunch Program

Current Free or Reduce benefits will expire October 13, 2025

- If you have previously filled out an application for benefits before July 1, of this year, you will need to fill out a new application, before October 13, for the 2025-2026 school year.
- Households receiving Food Share assistance do not have to complete a paper application. Your children will
 be directly certified and you will receive a confirmation letter by the first week of the new school year.
