Parents of resident non-enrolled students wishing to take courses in the School District of Slinger public schools shall apply in writing, to the principal of the public school they wish to attend. The letter of application shall include the name of the course requested, the rationale for the request, and the signature of the nonpublic school principal approving the request (parent in case of homeschooled student).

Written application for the entire upcoming school year shall be submitted by April 1. Participation will be considered by semester and final decisions by the District for each semester will be made after class sizes have been finalized but no later than one (1) week prior to the start of each semester.

Resident students, not enrolled in a School District of Slinger public school, are limited to participation in district programs as follows.

- 1. The course must be one which is not required to be offered in a home-based, private, or parochial school as defined under s.s. 118.165(1)(d).
- 2. Enrollment shall not be allowed in dual credit offerings, youth apprenticeship programs, youth options programs or to supplant any course offerings available to students through their nonpublic school studies.
- 3. Enrollment shall be limited to a maximum of two (2) courses during the school year in grades K-8 and during each semester at the high school if these criteria are met:
 - approval of the school principal for enrollment,
 - the student must be qualified academically to meet the course requirements (placement decisions will be made by the school principal),
 - the student must be a legal resident of the School District of Slinger,
 - the requested course is not at the maximum number of students for that grade and/or space is available without overcrowding the existing course as determined by the principal,
 - additional costs/expenses to accommodate the student shall not be incurred by the District,
 - parents shall be responsible for the appropriate course fees,
 - parents shall be responsible for all transportation arrangements, and
 - enrolled students shall be subject to all district and school regulations, and shall require regular attendance as well as compliance with conduct standards and expectations.

- 4. Enrollment in summer school classes (meeting the criteria above) shall be limited to two (2) classes, including driver education, upon approval of the superintendent or his/her designee.
- 5. At the discretion of the building principal, the student may be allowed to participate in an extracurricular activity. Activities eligible for this consideration are limited to those that require enrollment in a specific class as a condition of membership. The student must also meet any other eligibility criteria established for the activity.
- 6. The student may participate in the District's athletic programs as determined by state law and WIAA guidelines.

The School District of Slinger shall not discriminate in the provision of services or programs against any person because of that person's sex, race, color, national origin, ancestry, creed, religion, pregnancy, marital or parental status, sexual orientation, handicap or physical, mental, emotional or learning disability. Discrimination complaints shall be processed in accordance with established procedures.
