The committee reviewed and **MADE CHANGES** to the following policies:

- 421 Rule 1: 4K Registration Procedures – process is now online, not on paper
- 432 Rule Intradistrict Transfer of Elementary Students - process is now online.
- 432 Exhibit 2: Intra-District Transfer Request – DELETE, this is no longer used as the information is submitted online, not via a paper application
- 434 Student Release During the School Day – add “parent/legal guardian” to the policy
- 453.3 Rule 2: Control and Treatment of Head lice - adjust policy to reflect current state based on CDC and AAP recommendations
- 453.4 Administering Medications to Students - clarify language on self-administration with emergency prescriptions, which is allowed through State law
- 460 Rule Higher Education Academic Excellence Scholarship Tie Breaker Procedure - change two to three; remove weighting language, as how the GPA is determined is already articulated in Policy Rule 345.1
