1. Transportation Acknowledgement

The Slinger School District (referred to as “District” within the document) provides transportation to co-curricular activities whenever practical. Any transportation not provided by the District is considered **non-district transportation** and is not sponsored, supervised, or insured by the District.

2. Permission for Non-District Transportation

3. Driver Eligibility & Vehicle Requirements

 - Maintains automobile liability insurance meeting at least:
 - \$100,000 per person / \$300,000 per occurrence minimum (higher limits recommended)
 - Operates a vehicle that is properly registered and in safe operating condition
 - Has parental approval to operate the vehicle

4. Student Driver Safety Expectations

The student agrees to:

- Follow all traffic laws and regulations
- Use seat belts for all vehicle occupants
- Not use alcohol, drugs, or any impairing substances
- Avoid distracted driving (including phone use or other unsafe behaviors)
- Follow all Slinger School District policies and expectations

5. Assumption of Risk

I/We understand that transportation in a privately owned vehicle involves inherent risks, including injury or death. I/We voluntarily assume all risks associated with non-district transportation, including my student driving themselves or riding with another driver.

6. Release & Hold Harmless

To the extent permitted by law, I/We agree to release, indemnify, and hold harmless Slinger School District, its School Board, employees, volunteers, and agents from any claims, damages, or liabilities arising out of non-district transportation to or from school activities.

7. School Not Responsible for Private Transportation

I/We understand and acknowledge that:

- The District does not supervise or control non-district transportation
 - Student drivers are not acting as agents of the District
 - The District does not provide insurance coverage for privately owned vehicles

8. Authorization & Approval

Non-district transportation must be **approved in advance** by the appropriate school official (e.g., coach, advisor, or administrator).

This authorization applies to the full season/activity in the 2026-2027 school year.

The District reserves the right to deny or revoke this authorization at any time.
